Startup NEWS

Stellar Diagnostics India Pvt. Ltd.

- Featured in the India Health Fund Annual Report 2024–25 for developing the world's first point-of-care rapid TB triage test. The low-cost, 20-minute test is currently undergoing ICMR-led multi-centric clinical validation.

Dr. Jayanti Kumari

- Received the prestigious BIRAC Biotechnology Ignition Grant (BIG)-24 for OncoALERT, a rapid, field-deployable oral cancer screening tool aimed at enabling affordable point-of-care early detection.

Grailmaker Innovations Pvt. Ltd.

- Earned global recognition as Co-founder Ms. Prathyusha Potharaju received the Women Entrepreneur Award 2025 from Bayer Foundation and Impact Hub, along with a €25,000 grant and international mentorship support

ZenovoCare Technologies Pvt. Ltd.

- Showcased its first TENS and EMS medical device prototype at national platforms, including INCPT 2025 at AIIMS New Delhi, engaging clinicians and conducting market research to refine product development.

East Ocyon Bio Pvt. Ltd.

- Achieved significant national and international recognition with selection for Bharat Innovates 2026 and the Saudi Biotechnology Accelerator 2025, and contributed to key biotech forums as speakers, advancing bench-to-bedside innovation dialogue.

BBB Startups Apply for National Grants

- This year, eight BBB-supported startups applied for the BIRAC BIG 2025 grant, and three startups applied for Bharat Innovates 2026, a national deep-tech innovation showcase led by the Ministry of Education with guidance from the Office of the Principal Scientific Adviser.



New Startups Onboarded

Bharat Biomaterials LLP: A sustainability-driven startup developing Terratan™, a next-generation, plant-based composite material designed as an eco-friendly alternative to traditional and synthetic leather. The company transforms agricultural waste such as sugarcane bagasse, cactus, and other agro-residues into high-performance bio-based materials, enabling circular economy practices while addressing the environmental challenges of the leather industry.

Prateek Yadav: An agri-bio entrepreneur, developing a sustainable bioprocess to convert brewer's spent yeast into high-value, application-specific yeast extracts. Leveraging controlled autolysis with optional enzyme and chemical modulation, the innovation enables low-cost, customizable inputs for fermentation, food processing, animal feed, and biopharma applications. The venture aims to upcycle brewery waste into biotech-grade ingredients, supporting circular bioeconomy solutions that are Made in India & Made for India.

Alumni Spotlight

Vanguard Diagnostics Pvt. Ltd., a graduated startup of BBB, was recently awarded "Excellence in Diagnostics" by BioSpectrum. The recognition reflects the continued impact of the startup's innovation journey, supported by the mentorship and ecosystem at BBB.

INNOVATOR MIXER: WHERE IDEAS MET ENERGY

BSC BioNEST Bio-Incubator (BBB) hosted the Innovator Mixer on 16th October 2025, bringing together incubatees and innovators for an evening of networking, collaboration, and creative exchange. The event featured cultural and fun activities that helped build stronger connections, encouraged cross-pollination of ideas, and strengthened the startup community spirit at BBB.

BBB AT TIECON DELHI-NCR 2025: ENGAGING WITH INDIA'S DEEPTech FUTURE

The COO, BBB participated in TiEcon Delhi-NCR 2025, held on 30th October 2025. The event, themed “India’s DeepTech Ascent,” convened leading innovators, entrepreneurs, and ecosystem enablers to discuss emerging opportunities and advancements in the DeepTech sector.

IDEA IN ACTION: BIG 25 OUTREACH SERIES

Under BBB’s outreach initiative IDEA, a series of awareness and capacity-building sessions were conducted to support applicants of BIRAC’s BIG 25 scheme.

- Guidance Session with SINE-IIT Bombay (7 Nov 2025): Focused on understanding the BIG 25 scheme and preparing competitive proposals.
- Virtual Session with C-CAMP (13 Nov 2025): Covered BIG scheme overview, value proposition, product-market fit, and key success tips for applicants.
- Joint Grant Writing Session with KIIT-TBI (18 Nov 2025): Provided step-by-step guidance on the BIG application process and effective grant-writing strategies.

FOSTERING BIOTECH ENTREPRENEURSHIP: EXPERT TALKS FOR I3-BRIC PHD SCHOLARS

As part of BBB’s continued efforts to nurture entrepreneurial thinking among I3-BRIC PhD scholars, a series of expert talks were organized in November 2025. The sessions provided insights into translational research, healthcare innovation, and startup ecosystems:

- 3 November 2025: Dr. Suman Laal delivered a talk on “Tuberculosis Diagnosis: Challenges and New Opportunities,” highlighting unmet needs and innovation opportunities in TB diagnostics.
- 17 November 2025: Dr. Neetika Ashwani shared her journey in “ALKED ON: From the NICU to the Innovation Labs – Caring, Innovating, Impact!” bridging pediatrics, public health, and entrepreneurship.
- 25 November 2025: Mr. Chand Das conducted a session on “New Venture Planning – Angel Investor Perspective,” offering insights into the startup ecosystem and lessons from high-growth ventures.

These sessions equipped scholars with practical insights into entrepreneurship, innovation, and translational research, inspiring them to transform their research ideas into impactful biotech startups while providing strategies to navigate challenges in launching and scaling ventures.

REGULATORY INSIGHTS: NAVIGATING CLINICAL VALIDATION IN THE NUTRACEUTICAL SPACE

BBB in collaboration with VeritasQ Research & Analytics, organized Regulatory Affairs Session 4 on 7 November 2025. The session, titled “Nutraceutical Space – Clinical Validation and Its Importance in Emerging Markets,” was delivered by Mr. Devesh Kumar, Founder & Director of Innovate Research.

Mr. Kumar highlighted the crucial role of clinical validation in building credibility and enabling market access for nutraceutical products. The talk covered practical approaches to study design, regulatory compliance, and strategies to overcome infrastructure and cost challenges in emerging markets, providing valuable insights for startups navigating regulatory pathways.

HANDS-ON LEARNING: LFIA WORKSHOP EMPOWERS INNOVATORS

Under the Strategic Program LEARN, BBB, in collaboration with Stellar Diagnostics India Pvt. Ltd., conducted a hands-on workshop on “Design and Development of Rapid Serological Lateral Flow Immunoassay (LFIA)” on 18 November 2025.

The workshop offered participants practical training in assay development, covering reagent selection, optimization, and prototype creation. Attendees gained valuable skills to advance translational research in diagnostic assay development, bridging lab concepts with real-world applications.

DRIVING IMPACTFUL INNOVATION: BBB AT PFOI 2025

COO, BBB represented the incubator at the People’s Festival of Innovations (PFoI) 2025 held at IIC, New Delhi on 17th November 2025. She participated in the official launch of SAATHI (formerly IDSIA) and served as a panelist in the session “Social Alliance for Accelerating Transformative & High-Impact Innovations.”

During the session, she shared insights on supporting high-impact startups and engaged with ecosystem stakeholders to promote collaborative, transformative innovation initiatives.

BBB ENGAGES FUTURE INNOVATORS AT HEALTHTECH-IDEA 1.0

COO, BBB was invited as a Resource Person at the HealthTech-IDEA 1.0 National Conference-cum-Exhibition on 7 November 2025 at GD Goenka University, Sohna, Gurugram.

The event focused on innovation, development, and capacity-building for future healthcare entrepreneurs. In November 2025, BSC BioNEST Bio-Incubator (BBB), RCB strengthened its startup ecosystem through key partnerships:

- Wadhvani Foundation – National Entrepreneurship Network (NEN): BBB joined the Liftoff Program to support early-stage biotech, life sciences, and healthcare startups. This collaboration provides BBB startups access to a 12-week acceleration platform, expert mentorship, curated resources, and investor networks to enhance fundraising and scaling opportunities.

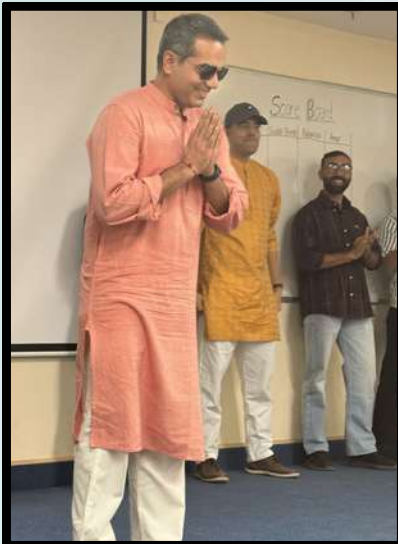

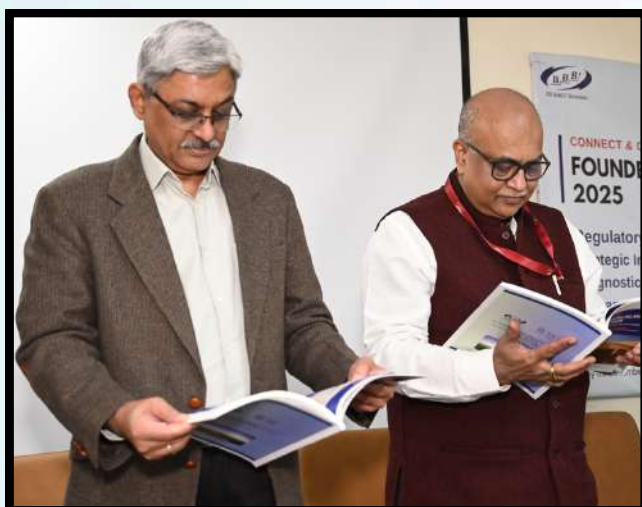

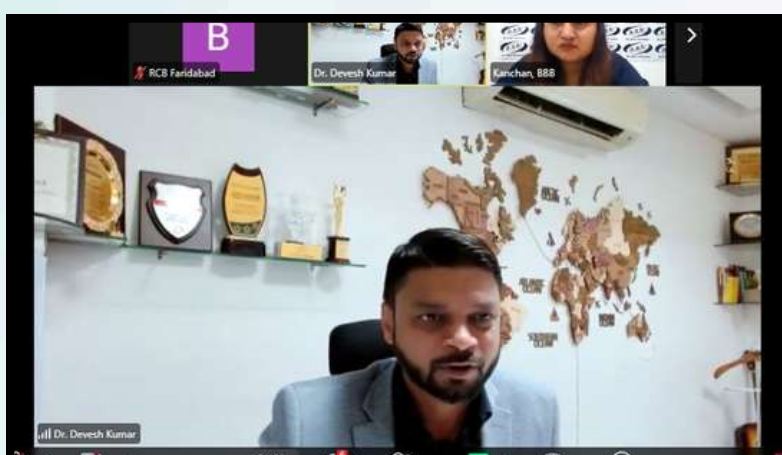
