- (iv) The payment will be made on actuals subjected to the ceiling upto the extent of quoted price against each items as mentioned above, after supply and satisfactory installation testing and commissioning of Green House, subject to certification by authorised representative of our Institute.

- (vii) CMC may be awarded for another period of 03 years post completion of warranty period at the discretion of the Competent Authority for a total cost of Rs. 1,26,000/-
