- 2. विक्रेताओं को सलाह दी जाती है कि वे अपना रेट कोटेशन जमा करने से पहले साइट पर जाकर प्रस्तावित कार्य का मूल्यांकन करें।
- 3. एजेंसी द्वारा अनुबंधों को उनकी कंपनी के लेटरहेड पर सावधानीपूर्वक भरा जाएगा और सील किया जाएगा NIQ दस्तावेज़ 01.07.2025, 11.30 बजे और उससे पहले आरसीबी रिसेप्शन पर जमा किए जाने चाहिए

- 1. The work shall be completed as per Schedule of Work, specification and instruction of Engineer-In-charge.
- 2. Venders are advised to visit the site to assess the proposed work before submitting their rate quotation.
- 3. Rate and amount filled section of the schedule given shall be filled by an agency carefully on their company letterhead and sealed NIQ documents should be submitted at RCB reception till 01.07.2025, 11.30 Hrs.
- 4. Deviation of Work deviation can be allowed of ±10 of total work order value.
- 5. No Advance payment shall be made.
- 6. Payment will be made as per the actual work done and measured.
- 7. Security deposit- 10% of completed work amount will be deducted from final bill payment and will be released after completion of Defects Liability Period (DLP) of 3Months.
- 8. During the defects liability period (DLP), if any work found in damaged/ repairable of executed work by agency, the agency shall repair it at own cost. The agency will not be paid separately by RCB
- Income tax shall be deducted from bills as per GOI rules for which contractor/supplier should have provided a copy of PAN No. and GST certificate in the name of registered company of proprietor along with NIQ for depositing TDS.
- 10. The rate should be inclusive of material, labor, freight, cartage, loading unloading, scaffolding and fixing etc. GST part should be shown separately.
- 11. Time allowed for completion for work shall be 30 days from date of issue of Work order.
- 12. The time allowed for the work shall be strictly followed otherwise the Contractor shall be liable to pay compensation at the rate of 0.2% of the ordered value of the work per day of delay on the part of the contractor subject to a maximum of 5% of the total ordered value.
