2.0 PRE-QUALIFICATION CRITERIA

1. The Tenderers must be OEM/ authorised service provider/ any agency or contractor having experience in the AMC/CMC of 2 × 1250 kVA transformers in Govt./PSUs/ Autonomous bodies or reputed private organization in the last Five years supported by documentary evidence and must have among list of big clients, at least two of such bodies. Certificates of satisfactory performance from at least three such clients of annual work order value of not less than ₹89,680/- have to be submitted along with tender.

In case of work completed in private sector, the bidder is required to submit TDS certificate of the work given in support of experience certificate

- 2. The tenderer should have at least similar work;
 - a) Three completed work, costing not less than an amount of ₹89,680/-,

OR

b) Two completed work, costing not less than an amount of ₹1,34,520/-,

OR

- c) One completed work, costing should not less than an amount of ₹1,79,360/-,
- 3. **"Similar work" means**, Annual Maintenance Contract services of Transformer Capacity 02 Nos x 1250 KVA or more in any of the organizations as stated above at SI No1.
- 4. Annual average financial turn over should be at least ₹1.80 lacs during the immediate last 3 consecutive financial years.
- 5. Agency must have its Service Centre/ office in Delhi NCR.
- 6. Even though the applicants meet the above criteria, they are subject to be disqualified if they have:
 - i) Made misleading or false representation in the form, statement and attachments submitted in and or
 - ii) Record of poor performance such as abandoning the work, not properly completing the contract, inordinate delays in completion, litigation history, or financial failures, etc.
 - iii) Found to have been black listed in any other works.

3.0 **REGISTRATION PROCESS**

- 1. Bidders to enroll on the e-Procurement module of the portal https://dbt.euniwizarde.com by clicking on the link "Bidder Enrollment". Enrolment on the e-wizard Portal is free of charge.
- 2. The bidders to choose a unique username and assign a password for their accounts. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the e-Wizard Portal.
- 3. Bidders to register upon enrolment their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India with their profile.
- 4. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse. Foreign bidders are advised to refer "DSC details for Foreign Bidders" for Digital Signature requirements on the portal.
- 5. Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token..

4.0 TENDER DOCUMENTS SEARCH

- 1. Various built in options are available in the e-Wizard Portal which is further synchronizing with CPP Portal to facilitate bidders to search active tenders by several parameters. These parameters include Tender ID, organization, location, date, value, etc.
- 2. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the Online Portal.
- 3. Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the Online Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 4. The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

5.0 BID PREPARATION

- 1. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid.
- 3. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 4. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black and white option.
- 5. Copy of constitution or legal status of the bidder manufacturer / Sole proprietorship / firm / agency etc.

- 6. Brochure, original technical catalogue with detailed specification and picture of the product offered, if relevant.
- 7. Earnest Money Deposit: The bidder will be required to deposit the Earnest Money Deposit **(EMD)** for an amount of ₹4,484/- **through Online portal.**

6.0 BID SUBMISSION

- 1. Bidder to log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2. The bidder to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3. Bidder to select the payment option as Online" to pay the tender fee/ EMD wherever applicable and enter details of the instrument.
- 4. A standard BoQ format has been provided with the tender document to be filled by all the bidders. Bidders to note that they should necessarily submit their financial bids in the prescribed format and no other format is acceptable.
- 5. Annexure-A has been provided with the financial bid of tender document to be filled by all the bidders.
- 6. However, Annexure A will be not considered in financial bid qualification. But any bidder got lowest rate in Annexure A, separately order will be issued to agency when required spare parts.
- 7. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 8. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data, which cannot be viewed by unauthorized persons until the time of bid opening.
- 9. The uploaded tender documents become readable only after the tender opening by the authorized bid openers.

8.0 TERMS AND CONDITIONS

8.1 GENERAL TERMS & CONDITIONS

- 1. In the event of non-commencement or unsatisfactory performance of the work contract, Centre (RCB) reserves the right to cancel the contract agreement or to withhold the payment. In such an eventuality, Centre further reserves the right to get the work done from some other agencies at the cost of bidding agency. The Agency will also be black listed by the Centre for a period of 5 years from participating in such type of tender and his earnest money/security deposit will also be forfeited.
- 2. It shall be presumed that the terms & conditions mentioned in the tender document including amendments/ corrigendum if any have been read, understood and duly accepted by the bidder. The bidder shall have no right to modify/ alter/ amend/ delete any terms/ conditions mentioned in tender document.
- 3. Tender forms are non-transferable. Only the original/downloaded complete tender form duly signed stamped, should be submitted.
- 4. Each page of the tender should be numbered and signed by the bidder/ Agency or his authorized signatory and duly witnessed with the seal of the firm.
- 5. Furnishing of wrong information and false documents will make the bidder ineligible for bidding and liable to be debarred/blacklisted from participation in Tender enquiries/Open Tenders/Annual Rate Contracts by the Centre. The EMD amount will also be forfeited.
- 6. The bidder will have to furnish documents in support of the information given in the tender. Original documents shall be checked for verification as and when required.
- 7. In case of any attempt for cartelization by bidder with a view to hike up the prices, all bids will be rejected and such bidders will be blacklisted and bid security will be forfeited.
- 8. If any required information /documents are not submitted, then the bid of the concerned bidder will be rejected. No representation in this regard will be entertained.
- 9. The bidders are expected to be present at the time of opening of bid; however, the bids will be processed even when no bidder /representative is present as per the declared schedule.
- 10. The decision of the Centre regarding approval of bids shall be final and binding on all bidders.
- 11. Annexure-A has been provided with the financial bid of tender document to be filled by all the bidders.
- 12. However, Annexure A will be not considered in financial bid qualification. However, any bidder got lowest rate in Annexure A, Spare parts rate will be freeze for one year and separately order will be issued to agency when required spare parts.
- 13. The agency shall **not** engage any **sub-contractor or sublet/transfer** the contract to any other agency/person in any manner.
- 14. The Executive Director, Regional Centre for Biotechnology reserves the right to:
 - A. Amend the scope and value of any contract under this NIT.

- B. Reject or accept any application without assigning any reasons thereof and reject all applications and cancel the Tender.
- C. The Centre/Employer/Consultant shall neither be liable for any such actions nor be under any obligation to inform the Applicants.

8.2 PERFORMANCE SECURITY DEPOSIT: -

Successful bidder must deposit the **Performance Security Deposit of 10% tender value** within 7 days after issue of Letter of Intent (LOI) in the form of Demand Draft/Bank Guarantee/ FDR from Nationalized/scheduled bank valid up to 15 Months from issue of work order, drawn in favour of "**Executive Director Regional Centre for Biotechnology**", Payable at Faridabad.

8.3 CONTRACT TENURE (EXTENSION)

- 1. The contract will be valid initially for **ONE YEAR** from the date of engagement of the agency.
- 2. After the completion of the assigned responsibilities during the initial tenure of the contract, Centre, at its sole discretion may extend the contract on year-to-year basis for maximum 03 years (01 Year initial +02 Years) based on satisfactory performance of the agency during the previous year(s).
- 3. In exceptionally deserving case, Centre, at its sole discretion and mutual consent, may consider further extension of the period of contact for which independent assessment of performance could be sought.
- 4. Centre will decide the date of commencement of the service, which will be duly notified at the time of Award of Tender.

8.4 VALIDITY OF THE BIDS:

- a) The bids shall be valid for a period of 365 days from the date of opening of the tender. This has to be so specified by the tenderer in the commercial bid.
- b) **Warranty / Guarantee:** Bidder must provide 06 months warranty for the replaced spare parts. and it will start from the date of the satisfactory installation / repair against the defect of any manufacturing, workmanship and poor quality of the components. No offer of the vendor will be accepted without warranty/ guarantee of their supplied/ installed goods.
- **8.5 PAYMENT TERM:** The payment for services rendered shall be made on presentation of bills in triplicate pre-receipted, along with service reports of each quaterly during AMC billing period and should be Certificate from the respective user wing for performing satisfactory service on quaterly basis.
 - a) The payment for services rendered shall be made through electronic clearing system.
 - b) After successful completion of half yearly AMC services, agency should be submitted service report of the both transformer along with invoice and spare parts/consumable list (after successful completion of each half yearly).
 - c) No payment will be made for goods rejected.
 - d) The above rates must be inclusive of all applicable Taxes, handling and freight charges,

- to and fro conveyance of service engineers etc.
- e) The party shall be deemed to have visited to the site, understood the work prior to quoting of rates.
- f) However, bidder should mention rate of applicable GST. In case applicable GST rate is not mentioned by the bidder in price bid; then it will be assumed that their quoted rates are INCLUSIVE of all GST.
- g) Income tax and any other taxes shall be deducted from the agency bill as per govt. of India rules

Note: Repeat order or part quantity can be ordered after completion of work or before 01 years on same rate terms & conditions. A payment will be made as per actual measurement basis.

- **8.6 PENALTY** The follow penalty will be imposed in case of non-operation of Compact Substation (CSS).
- 1. In case of any defaults, the agency is failed to attend the complaints within 48 hours of intimation/ registration of complaint, shall be authorized to levy Rs. 5000/- or 1% of the contract value, whichever is higher, as a penalty for each default, and in case of three consecutive defaults, necessary action will be taken against the defaulter by the Competent authority of RCB.
- 2. In case the agency fails to commence the work as stipulated in the agreement, after 02 weeks delay, RCB reserves the right to cancel the contract and withhold the agreement and forfeit the EMD as applicable and get this job to be carried out at the cost and risk of the Agency.
- 3. The defaulting Bidder/ Agency will be blacklisted from participating in any tender of RCB for next five years.
- 4. For any other breach of contract, Designated Committee or Authority or any person nominated by or on behalf of the RCB, shall be entitled to impose a penalty up to as given in table below.
- 5. Some of the instances in which penalty would be imposed are enumerated below. But these are not exhaustive and penalty may be imposed on any violation/breach or contravention of any of the terms and conditions as well as assigned duties and responsibilities).
- **8.7 TERMINATION OF CONTRACT** This contract may be terminated at any time by either party on 30 days written notice. Any refunds or additional charges, as the case may be, shall be on a pro-rata basis.
- **ARBITRATION ON DISPUTE:** The Courts at Faridabad will have the jurisdiction to try any matter, dispute or reference between the both parties arising out the contract. It is specifically agreed that no Courts of outside Faridabad shall have jurisdiction in the matter.
