1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

2. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM of the product offered in the bid {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts and delivery acceptance certificates like CRAC to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

3. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 80% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. Technical Specifications for 2 complete units of “Mice Individually Ventilated Cage System (IVC) with cages and bottles”

(1 IVC system = 1 IVC AHU + 2 Double Sided IVC Racks + 192 or more mice cages and bottles for the quoted model to be supplied by the vendor with the whole system)

1) Air Handling Unit

- a. Air handling unit should be independent and not mounted on the rack.
- b. Provision to link two double sided racks to the air handling unit.
- c. Both supply and exhaust air stream should be HEPA filtered.
- d. AHU should provide minimum 60-80 air changes/hour.
- e. HEPA filters should be DOP Tested. The efficiency level of the filter should be 99.99% to prevent the 0.3 micron particles.
- f. AHU should have control panel with display and provisions for monitoring, setting and controlling of all required parameters. The controller should be capable for necessary logging of basic parameter data up to a period of one year.
- g. The system should have built in safety devices/alarm indicating system's failure (for critical parameters like temperature, relative humidity and cage pressure) and filter choking.
- h. AHUs should be of stainless steel 304 and should have provision of castor wheels with locking system.
- i. Exhaust system should have provision to be attached to room's exhaust system, and is under the scope of the agency.
- j. The cages should be individually ventilated and be able to run in both positive and negative pressure modes as per requirements which can be changeable via the AHU control panel.

2) Racks

- a. The total height of the rack should not exceed 7 feet.
- b. Racks should be of Stainless Steel AISI 304.
- c. Each rack should accommodate a minimum of 96 cages in a double sided mode.

d. The rack should allow easy placement and removal of the cages and should have system for proper cage stopping or locking.

e. Provision of PU castor wheels with locking system.

f. The racks should be having laser engraved metallic stickers or their equivalent attached on rack for reference of column and rows (to mark/define the location of cage with in the rack).

3) Cages and Bottles

a. Cages should be made of polysulphone or equivalent material and should be transparent enough to reveal the contents inside.

b. All components of the cages must be washable and autoclavable. It should have ability to withstand the repeated autoclaving at 121 degrees centigrade.

c. Floor area of the cage should be more than 500 cm² with the minimum cage height of 12 cm.

d. Cages should have microbiological filters. Apart from the filters fixed into cage lids, three extra set of microbiological filter (192 or more cages x 3) for mice cages should be provided for required future changes for maintenance purpose.

e. Cage system should have appropriate gaskets between the cage top and cage body for sealing purpose.

f. Nozzle of the water feeding bottles should be leak proof.

g. Cages should have autoclavable cage card holders, and these card holders should be having double or single hook on their rear face to be attached to cages firmly, and must not get detached easily from cage with any minor accidental touch/ force (to prevent chances of switching/ losing of cage's ID/details).

h. The total Minimum number of Cages (Cage top, Grill and Cage bottom, Cage's card Holder) and Bottles (Sippers/ nozzle and bottles) to be supplied along with one IVC system (comprising two double sided IVC rack) should match the total number of cages that can be accommodated into two double sided IVC racks for mice (i.e. 192 or more).

4) Noise level generated from the unit should be less than 60 dBA.

5) The system should follow the Indian Electrical Standards (Electricity requirements such as 220-240V 50 Hz suitable for Indian power systems).

6) Pre-installation and utility requirements (if any) for installation and running the system should be clearly mentioned.

7) Vendor should provide power backup in the form of UPS with required capacity to run the AHU for minimum 30 min-1 h in case of power failure .

8) The Vendor should provide the complete applicable validation documents (IQ, OQ and P Q) inclusive of quality assurance testing for ventilator for HEPA filters (DOP) and sensors used at the time of installation and performance verification at site.

9) The system should have five years of comprehensive on-site warranty for entire system including the replacement of all parts (pre filters, HEPA filters, microbiological filters, cage accessories and bottle gaskets).

10) A minimum of three installations proof in any of the Government organizations should be provided.

11) Equipment should be quoted along with 05 Years comprehensive onsite warranty.

12) Installation of the instrument and accessories should be done free of cost from vendor's side. Vendor has to make own arrangements for manpower/labour involved for shifting and carrying out the installation. Institute will not provide any kind of labour support.

13) There should be after sales service support available in Delhi-NCR region.

For Procurement Goods & Services
