Subject: Regarding recruitment for the post of FINANCE OFFICER

Regional Centre for Biotechnology vide Advt. No. RCB/01/2026/Recruitment/HR dt. 25.03.2026, invited online applications for filling-up ONE post of Finance Officer (01-UR) in pay level 13 of Pay Matrix as per 7th CPC. The last date of receipt of applications was 22.05.2026.

2. The Screening Committee duly constituted by the Competent Authority met on 31.07.2026 and scrutinized the applications of the applicants in the light of Prescribed Educational and other qualifications required and the 'General Terms and Conditions' of the advertisement for this post.

3. The Committee carefully scrutinized all the received applications based on the criteria mentioned in the advertisement and decided the following:

(A) The candidates having CA/CS/ICWA qualification would be considered equivalent to the post-graduation degree.

(B) The candidates having PG Degree through Open & Distance Learning/ Online Learning are required to submit relevant proof of recognition of the course.

(C) All the provisionally shortlisted candidates are required to submit the Post Graduate Degree qualifying date (DDMMYYYY format) along with supporting document (copy of degree/marksheet).

(D) All the provisionally shortlisted candidates are required to submit the pay slips as a proof of 'at least 05 years' regular service in a position carrying Pay Level 12 or 8 years' service in a position carrying Pay Level 11.

(E) For considering the pay equivalency in case of candidates with Private employment/ PSU, the applicants are required to submit their salary slips for equating the requisite Basic Pay and DA of CDA pay level.

(F) All the provisionally shortlisted candidates are required to submit their experience details in DDMMYYYY format along with supporting documents (experience letter etc.).
