- 1. Earnest Money Deposit (EMD) amounting to Rs 23,000/- In the form of Demand Draft drawn in favor of the Executive Director RCB, payable at Faridabad shall be submitted along with the bid without which the tender will be summarily rejected.
- 2. The Supply shall be done as per specification, terms & conditions and as per the instruction of the Engineer- in-Charge.
- 3. The tenderers may visit the site and assess the scope of works before submitting their offer.
- 4. Duly sealed tenders shall be dropped in the tender box placed at the reception counter of the RCB.
- 5. The Executive Director RCB, reserves the right to cancel any or all the tenders without assigning any reason.
- 6. All materials brought at site shall be got approved from the Engineer-in-charge' before being used.
- 7. The tenderers should have office/service centre in Delhi & NCR.

- 15. Time allowed for the work shall be strictly followed otherwise the contractor shall be liable to pay compensation at the rate of 0.5% of the ,contract value of the job undone per week of delay on the part of the contractor subject to a maximum of 5% of the total contract value.

However, for any reason beyond the control of the contractor the extension of time shall be granted upon application by the contractor in prescribed format. No claim for any compensation during the extended period shall be entertained and the owner's decision in this regard shall be final.

- 16. Earnest money deposited (EMD) by the successful tenderer shall be adjusted/ can be released against performance deposit. Performance deposit will be released after three months of expiry of contract.
