Those candidates who have passed any of the above mentioned examinations in the concerned trade, registered themselves on the Apprenticeship Portal (website) during the last 3 years and have not availed the Apprenticeship Training, may submit their applications in the prescribed proforma to the Institute within a 21 days of advertisement publication through online mode only. The prescribed proforma of the application is available on the Institute's website www.rcb.res.in.

Applications received in response to this advertisement will be scrutinized based on certain criteria fixed by the Institute and only such shortlisted candidates as eligible as per the screening criteria will be asked to attend the interaction by e-mail/publication on the Institute website.

The columns regarding full postal address, email ID, mobile number and Apprenticeship registration number in the applications must be filled up by the concerned candidates, failing which the applications will be treated as incomplete and will be rejected.

**Selection process:** Selection shall be based on merit as per mark secured in the degree/ diploma course as mentioned against each Apprentice posts.

**Age limit:** Maximum age 28 years as on 01-01-2023, but not less than 14 years. Age relaxation is allowed for Scheduled Caste/ Scheduled Tribe/ Other Backward Classes/ Persons with Disability/ Ex-servicemen, as per applicable Govt. of India rules. ¬ Reservation for Scheduled Caste/ Scheduled Tribe/ Other Backward Classes (NCL)/ Persons with Disability/ Economically Weaker Section, will be as per existing Govt. of India rules.
