Subject: DBT-Junior Research Fellowship (DBT-JRF) and DBT- Research Associateship (DBT-RA) National Program – Extension of Fellowship due to COVID-19 Pandemic.

Department of Biotechnology, Ministry of Science and Technology, Government of India taking cognizance of COVID19 pandemic on planned research work of Fellows working under DBT-JRF and DBT-RA (National Program), has approved the extension of the tenure of the fellowship for a period of up-to six months with 50% Fellowship (including HRA) to complete the research work originally planned and suffered due to lockdown.
