TERMS AND CONDITIONS

- 1. The work shall be completed as per Schedule of Work, specification and instruction of Engineer-In-charge.
- 2. Vender are advised to visit the site assess the proposed work before submitting their rate quotation.
- 3. **Annexures** will have filled by agency carefully on their company letterhead and sealed NIQ documents should be submitting at **RCB reception on 28.11.2024 and before 11.30 Hrs.**
- 4. **Deviation of Work -** deviation can be allowed of ±20 of total work order value.
- 5. No Advance payment shall be made.
- 6. **Payment** will be made as per actual work done and measured.
- 7. **Security deposit** 10% of completed work amount will be deducted from final bill payment and will be release after completion of Defects Liability Period (DLP) of 3 Months.
- 8. During the defects liability period (DLP), if any work found in damaged/ repairable of executed work by agency, the agency will have provided and repaired it at own cost. The agency will not be paid separately by RCB.
- 9. Income tax shall be deducted from bill as per GOI rules for which contractor/supplier should have provide a copy of PAN No. and GST certificate in the name of registered company of proprietor along with NIQ for depositing TDS.
- 10. The rate should be inclusive of material, labour, freight, cartage, loading unloading, scaffolding and fixing etc. GST part should be shown separately.
- 11. **Time allowed** for completion for work shall be **14** days from date of issue of Work order.
- 12. The time allowed for the work shall be strictly followed otherwise the Contractor shall be liable to pay compensation at the rate of 0.2% of the ordered value of the work per day of delay on the part of the contractor subject to a maximum of 5% of the total ordered value.
